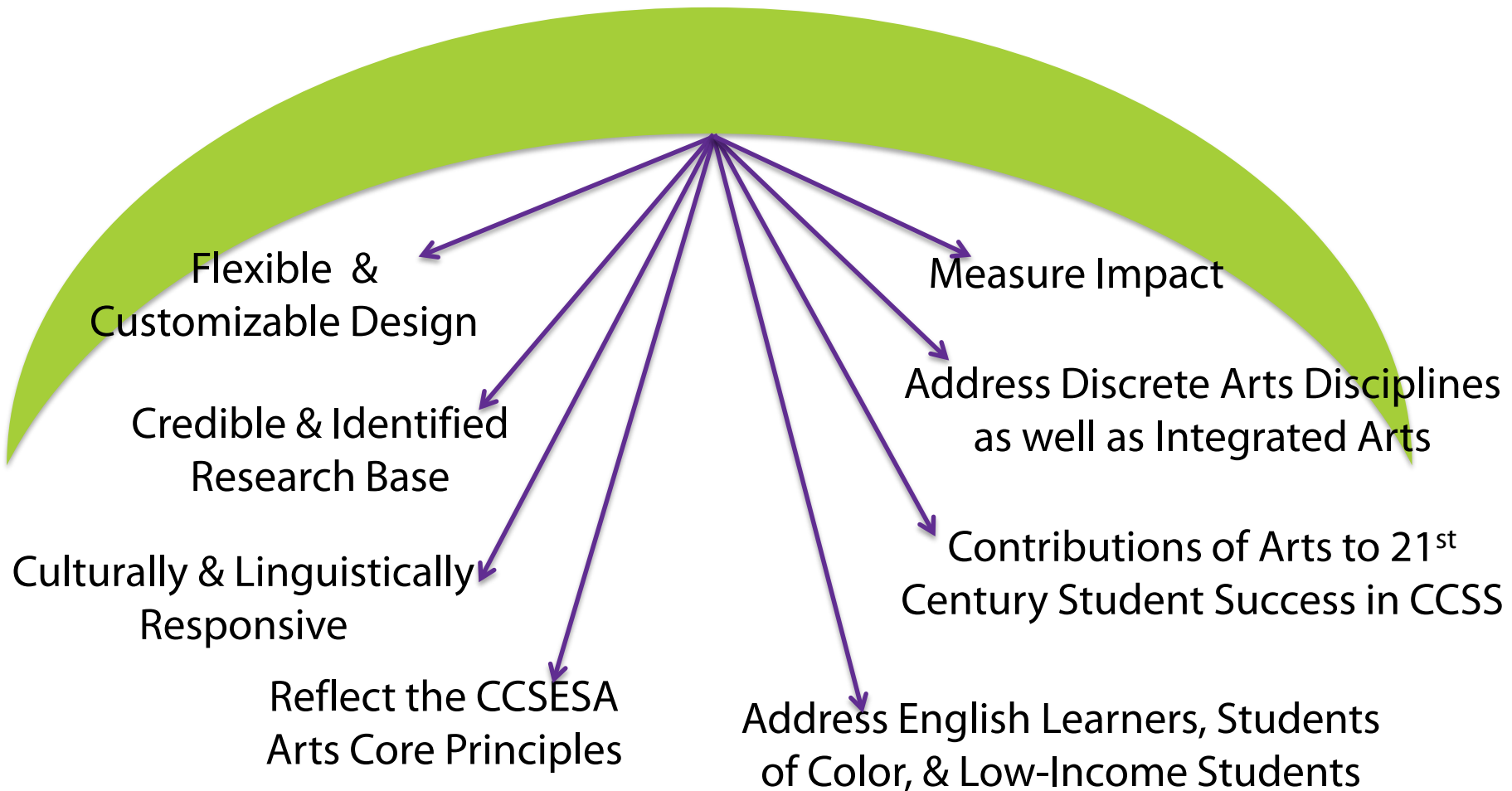
Our Challenge
